

Point Maester Gun Dogs Puppy Health & Performance Guarantee

For Purebred, Fully Trained & Field-Started GSP Puppies

Point Maester Gun Dogs (“Seller”) is committed to producing healthy, well-bred, sound, and professionally trained German Shorthaired Pointers. Each puppy is raised with exceptional care, handled daily, and given a foundation appropriate for a future hunting, competition, or family companion.

This agreement outlines the full health and replacement guarantee for puppies purchased from Point Maester Gun Dogs.

SELLER AGREES:

1. Veterinary Care & Records

Point Maester Gun Dogs guarantees that each puppy has received proper veterinary care, age-appropriate vaccinations, and deworming prior to transfer. A complete health and shot record will be provided at the time of sale.

2. Congenital Health Guarantee (12 Months)

The puppy is guaranteed against any **life-threatening congenital defect** resulting in death or medically necessary euthanasia within **12 months** of age.

If such a defect is diagnosed:

- Buyer must provide a written veterinary report from a licensed veterinarian describing the congenital condition.

- Point Maester Gun Dogs reserves the right to seek a second veterinary opinion.
 - Upon confirmation by both veterinarians, the Seller will provide a **replacement puppy of comparable quality from the next available litter.**
 - **Training fees are non-refundable**, as training services occur prior to diagnosis.
 - Seller does not reimburse veterinary expenses under any circumstance.

3. Seven-Day Initial Health Guarantee

Buyer has **seven (7) days** from the date of receiving the puppy to have them examined by a licensed veterinarian.

If a genetic condition posing a serious risk of death or euthanasia is discovered:

- Buyer must notify Seller immediately and provide a written veterinary report.
- Upon verification, Seller will offer a replacement puppy from upcoming litters.
- Communicable diseases contracted after the puppy leaves Seller's possession are not covered.

This guarantee does **not** cover:

Parasites, worms, fleas, mites, coccidia, giardia, dental issues, or other commonly treatable conditions.

4. Hip Dysplasia Guarantee

Point Maester Gun Dogs offers a **12-month guarantee** against **moderate or severe hip dysplasia**.

Conditions:

1. Puppy must receive an initial diagnostic x-ray from Buyer's veterinarian.
2. A copy must be sent to Seller and Seller's veterinarian for confirmation.
3. Buyer's veterinarian must certify that:
 - The dog was not overfed or underfed.

- The dog was not raised on slippery flooring.
- The dog did not receive excessive forced exercise.
- A high-quality diet with proper protein/calcium ratios was fed.
- X-ray was not taken during a female's heat cycle.

If the condition is believed to be genetic, Seller will refund **50% of the puppy's purchase price** (training fees excluded).

OFA Confirmation Requirement

- OFA evaluation cannot be completed until 24 months of age.
 - Seller grants a **13-month extension** solely for OFA confirmation.
 - No refund will be issued until OFA certifies a **moderate or severe** dysplasia diagnosis.

5. Heart Murmur Guarantee

Seller provides a **12-month guarantee** for **severe congenital heart murmurs (Grade 5/6 or 6/6)**.

- Diagnosis must be confirmed by a board-certified canine cardiologist via echocardiogram.
 - Buyer may choose:
 - A)** Return the puppy for a *full refund*, or
 - B)** Keep the puppy and receive a *50% refund* of purchase price (training fees excluded).

6. DNA Verification

Seller reserves the right to request DNA testing to confirm lineage or verify identity in any guarantee or replacement situation.

7. Training Disclosure

Point Maester Gun Dogs provides puppies that are **field started, crate trained, and obedience-conditioned**, but no guarantee is made regarding long-term performance, temperament, or future trainability, as these are affected by the buyer's ongoing handling.

BUYER AGREES:

1. Veterinary Examination

Buyer must have the puppy examined by a licensed veterinarian within **seven (7) days** of possession.

2. Pet, Sporting, or Companion Use Only

Puppies sold by Point Maester Gun Dogs are sold **without breeding rights** unless a separate, written breeding agreement is executed.

- If the dog is bred without authorization intentionally or accidentally. Buyer agrees to pay Seller, the full value of the dog *and* the full market value of all offspring.
 - This condition follows the dog in all future transfers of ownership.

3. No Veterinary Reimbursement

Buyer agrees that Seller does **not** reimburse veterinary bills after the puppy leaves Seller's possession. Pet insurance is strongly encouraged.

4. Required Health Maintenance

Buyer agrees to:

- Provide annual veterinary exams.
 - Maintain up-to-date vaccinations and parasite prevention.
 - Feed a high-quality diet appropriate for an athletic sporting breed.

5. Spay/Neuter Requirement

Unless otherwise agreed in writing, Buyer must **spay or neuter the dog between 12–18 months of age** to support optimal skeletal development in sporting breeds.

No litter may be produced.

6. Rehoming Policy

Buyer agrees **never to surrender the dog to a shelter or rescue**.

If rehoming becomes necessary, Buyer must find a suitable home. Seller will assist at Buyer's request, but **no refund will be issued**.

7. Value Limitations

The guaranteed value of the dog is limited to the **original purchase price**, excluding:

- Training fees
 - Delivery or shipping fees
 - Veterinary bills
 - Emotional valuation
 - Boarding or handling fees

LIMITATIONS & CONDITIONS OF GUARANTEE

The guarantee is **void** if:

- The dog is allowed to become **obese or underweight**.
- Evidence of **abuse, neglect, trauma, or injury** exists.
 - The dog is bred without written permission.
- The dog is fed a poor-quality or nutritionally unbalanced diet.

Buyer is responsible for:

- All transportation costs for evaluation or replacement.
- All veterinary costs (except those borne by Seller's veterinarian during second-opinion review).

The guarantee is **non-transferable** and valid only for the original buyer.

CLAIM REQUIREMENTS

- All claims must be supported by documentation from a licensed veterinarian.
 - Reports must clearly state that the defect is **congenital in origin**.
- Claims must be submitted **before the dog's first birthday**, except where OFA extensions apply.
 - In cases of sudden death, Buyer must provide:
 - A veterinary statement, and
 - A necropsy report confirming congenital cause.

PAYMENT & ACTIVATION

Guarantee is valid only upon **full payment** of the purchase price. If any discount was provided, Buyer must pay the difference before guaranteed activation.
